## Anti-Ragging Policy: Rules, Regulations, and Do's & Don'ts

In line with the legal framework outlined by the University Grants Commission (UGC) and the Government of India, this document provides clear rules and regulations along with Do's and Don'ts for students and staff. The purpose is to raise awareness about ragging and its legal consequences under Indian Penal Code (IPC) provisions.

## 1. Rules and Regulations Regarding Anti-Ragging:

#### 1.1 Definition of Ragging:

Ragging is defined as any act that affects the dignity of students and may cause emotional or physical harm. It includes, but is not limited to, bullying, verbal abuse, humiliation, forced consumption of alcohol or drugs, and any behavior that threatens a student's safety or well-being.

## 1.2 Prohibition of Ragging:

Under the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions (2009), ragging in any form is prohibited. Any student involved in ragging, whether directly or indirectly, is subject to disciplinary action as per institutional policies and Indian laws.

## 1.3 Legal Provisions and Consequences under IPC:

Ragging constitutes a criminal offense under various sections of the Indian Penal Code (IPC), including:

Section 341 (Punishment for Wrongful Restraint): If ragging involves wrongful restraint or confinement, the perpetrator is liable for punishment.

Section 323 (Punishment for Voluntarily Causing Hurt): If ragging leads to physical harm, the perpetrator can face imprisonment or a fine under Section 323.

Section 324 (Voluntarily Causing Hurt by Dangerous Weapons or Means): If the act involves the use of dangerous substances, the offender may face severe legal action.

Section 506 (Punishment for Criminal Intimidation): If ragging involves threats or intimidation, the offender can be punished for criminal intimidation.

Section 354 (Assault or Criminal Force to Woman with Intent to Outrage Her Modesty): Any ragging act that involves the molestation or harassment of a female student falls under this section.

Section 307 (Attempt to Murder): If ragging leads to serious injuries or threats to life, it can be considered an attempt to murder.

## Do's and Don'ts for Students

### **Do's (Expected Behavior)**

- 3. Follow College Regulations: Adhere to the college's rules regarding behavior, conduct, and participation in extracurricular activities.
- 4. Support Victims: If you witness ragging, take proactive steps to assist the victim and inform authorities.
- 5. Be Aware of Legal Implications: Understand the serious consequences of ragging, which can lead to expulsion or legal action under the IPC.

## Don'ts (Prohibited Behavior)

- 1.Do Not Engage in Ragging: Any form of ragging, including physical, verbal, psychological abuse, or any form of harassment, is strictly prohibited.
- 2. Do Not Force Consumption of Any Substance: Forcing a fellow student to consume alcohol, drugs, or any other substance is considered ragging and is a punishable offense.
- 3. Do Not Use Intimidation or Threats: Any act of intimidating, bullying, or threatening a student, physically or emotionally, is strictly forbidden.
- 4. Do Not Isolate New Students: Avoid any form of bullying that isolates a student or puts them in a vulnerable position.
- 5. Do Not Share Personal Information Without Consent: Refrain from sharing, spreading rumors, or using personal information inappropriately to harm others.
